

**Proceedings of Annual General Body Meeting of SAPI held on 19.2.2020 at CSWRI,
Avikanagar, Rajasthan.**

The **Annual General Body Meeting** of Society of Animal Physiologists of India (SAPI) held on 19.2.2020 at CSWRI, Avikanagar, Rajasthan (on the second day of XXVIII Annual Conference). 2. Statement of Accounts of SAPI for the year 2018-19.

- c. Contestant should have at least 25 years of professional experience in Animal Physiology.
- d. Contestant should be of above 50 years age.
- e. Contestant should have worked as Executive committee member.
